quality selection

The qualities detailed in the matrix above represent specifications which should satisfy most commercial requirements. With each particular installation, the decision on which quality is most appropriate will depend on the levels of traffic and the length of time the carpet is expected to be installed.

Gaskell Mackay have many years of experience in these considerations and provide detailed advice on quality selection on a project by project basis. Technical specifications are available on request.

colour and design

Colour and the presence or absence of a pattern can have a significant bearing on the long term appearance retention of the carpet. As a general rule, darker red, brown and grey tones are much less sensitive in displaying soiling than the equivalent blue, green or purple shades. All light colours are dirt sensitive, while highly patterned carpets tend to hide dirt, cigarette burns and stains.

Other aspects will also influence the choice of colour. For example, the light in a building (natural or artificial) can have a dramatic effect on the apparent colour of the carpet. Therefore carpet samples should be viewed under different light sources to ascertain their apparent colours.

planning and estimation service

Using the latest Callidus planning software, Gaskell Mackay can accurately estimate carpet requirements from site plans to any scale. Accurate waste estimations can be readily calculated and adjustments made to minimise this.

One critical area of importance is seam placement. Knowledge of customer flow through the area is used to guide the fitter in the careful positioning of seams to avoid premature wear. The planning and estimation service is free.

samples

installation

The 'Infinity' range of carpet qualities which includes Windermere, Derwent and Coniston are produced on a revolutionary new, high speed axminster loom and are woven without a traditional selvedge. The selvedge is trimmed during manufacturing as close as possible to the pile. Normally this allows the carpet to be joined without necessity for further trimming of the selvedge. The uniquely formed selvedge may however be trimmed by the installer if he feels the carpet has not been trimmed sufficiently to the pile and would leave a gap after seaming. Fusible yarns are woven into the selvedge to provide extra pile anchorage.

It is essential to seal the back of the carpet before cutting, particularly on cross cuts and then seal the cut edge to prevent fraying. The carpet may be seamed with heat seaming tape or electroseaming tape (e.g. 'Silvaseam). The carpet may be hand sewn if this is specified for border work after the carpet has been sealed and cut.

In all other respects the carpet should be installed in accordance with BS5325 (Code of Practice for the Installation of Textile Floorcoverings) and NICF Carpet Installation Manual by a trained axminster carpet installer.

There are a number of ways in which the 'Infinity' range of Gaskell Mackay qualities can be installed including stretch fitted over a suitable contact underlay on to gripper, full adhesion to a prepared subfloor or installed on double stick underlay systems. Installation on double stick underlay systems should be in accordance with the recommendations issued by Gaskell Mackay Carpets Ltd.

maintenance

Effective dirt barrier systems must be fitted in footwells in, or immediately adjacent to external entrances. Carpet maintenance must be carefully planned and this plan implemented from the moment the carpet is installed.

Maintenance methods and levels must be tailored to foot traffic intensity to prevent both inadequate or unnecessary cleaning. A cleaning schedule usually includes three levels of cleaning.

- I. Regular maintenance (Daily vacuum cleaning and spot removal).
- 2. Intermediate "wet" cleaning or surface brightening.
- 3. Deep or restorative "wet" cleaning.

Depending on how effective the regular (usual daily) maintenance is, then intermediate cleaning will have to be used eventually. Effective intermediate cleaning can often postpone the need for restorative cleaning, all of which will save maintenance costs. Correct and regular maintenance will also be cost effective by increasing the lifespan of the carpet.
